Violation #56. Ventilation & lighting

Observed staff food stored at reach-in refrigerator. Remove food and assign an area to store personal food items.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
