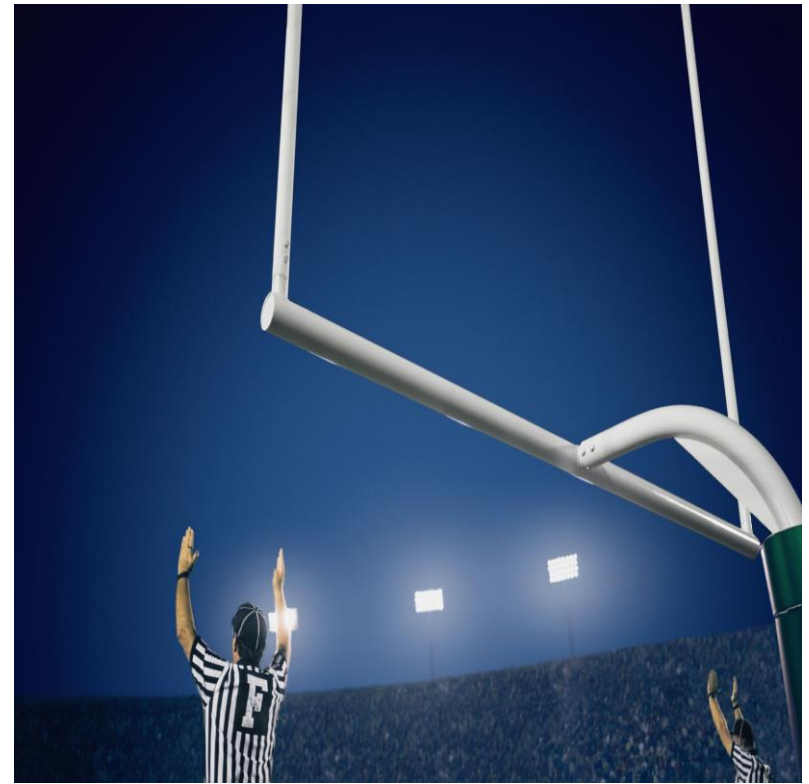

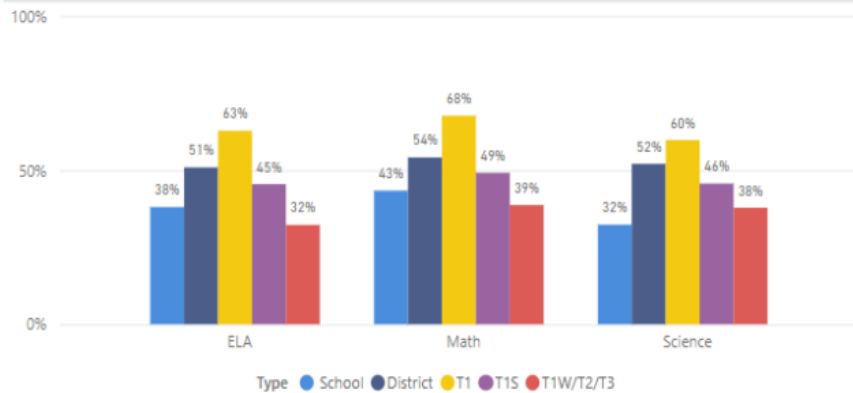

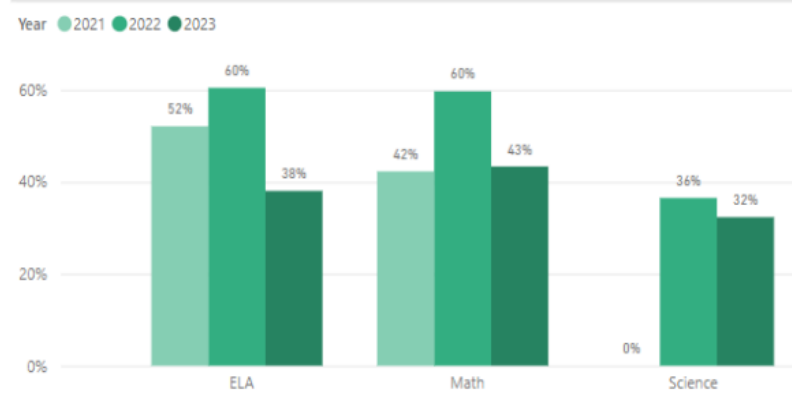

2023 FAST/EOC Proficiency - District/Tiered Comparison

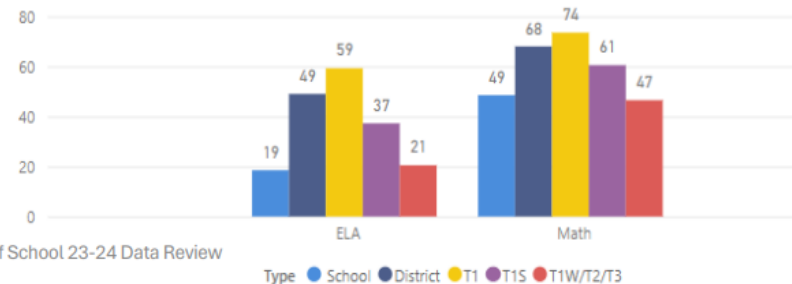


Three Year Trend - FAST/FSA/EOC Proficiency
